- (VIII) That the development of an open democratic society based on effective, representative institutions, formed from among the citizens through fair and free elections is the best guarantee, and for social consciousness.
- (IX) That political power should be used to secure the evolution of a more just society in which the contributions to and rewards from the society are made not on the basis of equal opportunity, merit and ability.
- (X) That the productive resources of Barbados, namely land, labour, capital, technology and management should be so mobilized as to create wealth, protect and promote a sound economy within the global context, and to provide over time rising output, increasing employment opportunities, relatively stable prices, a stable exchange rate, and rising standards of living.
- (XI) That the instrument of economic policy and economic activity should serve the needs not of a privileged few but of all inhabitants, in a new and more caring economic and social order; and that the concepts of economic enfranchisement should be utilized to create the greatest measure of social betterment, to eliminate untenable imbalances and disparities, to improve the distribution of income and wealth, and to eradicate the remaining pockets of poverty.
- (XII) That sustainable development and protection of the environment are key concepts for achieving the social and economic wellbeing of the people of Barbados.
- (XIII) That the effective creation and distribution of wealth in Barbados is dependent upon the furtherance of mixed market economy characterized by:
 - (a) A vibrant profit-oriented private sector;
 - (b) An impartial, efficient and responsible public sector;
 - (c) A tempering of the profit motive by social commitment;
 - (d) The widest possible distribution of shares and financial and other assets among the inhabitants so that a much wider pool of individuals and groups can have a stake in the operation of the economy;

- (e) A harmonious balance between the interest of capital and labour; and
- (f) Effective and timely public sector intervention to correct market failures.
- (xiv) That the right, freedoms and aspirations of the inhabitants of Barbados can best be sustained under the strong, affordable regime of law, order and national security which acts as a bulwark against illegal and unjust challenges either from within or without
- (xv) That a sound labour relations climate should be maintained at all times through any or all of the following means:
 - (a) Support for progressive labour legislation;
 - (b) Encouragement or workers to join and participate in the activities of trade unions which are democratically organized, properly run, financially sound, and genuinely dedicated to the timely interests of the workers;
 - (c) The creation of good working conditions;
 - (d) The maintenance of an equitable system of wages, hours of work, holidays and other fringe benefits;
 - (e) Promotion of the processes of collective bargaining through employers' organizations on the one hand and workers' organizations on the other;
 - (f) The establishment and maintenance of machinery for the conciliation and arbitration of disputes.
- (xvi) That the conditions for a more meaningful, constructive and representative democracy at the community and constituency level should be created by strengthening the role of Members of Parliament at that level, thereby ensuring a greater involvement in the responsiveness to the interest of societal groups such as families, youth groups, churches, clubs, organizations and associations.
- (xvii) That an appropriate framework for the maximum possible cooperation and integration among Caribbean peoples and states should be devised in recognition of the common threads of history, culture, economic situations, and aspirations of the people of the region.
- (xviii) That the people of Barbados should participate in regional, hemispheric or worldwide meetings and organizations in pursuit of the goal of world peace, democracy, international understanding and economic justice among nations.

(xix)	That the integrity of the nation is entirely dependent upon the
	integrity of the individual and group within it, and that every
	effort should be made to inculcate virtuous behavior among the
	youth and adult of our nation through the acceptance and practice
	of civic, moral and religious values.

- (xx) That honest and responsibility in public life should be secured and maintained at all times, and that graft and corruption, wherever they may exist, should be rooted out by every constitutional means.
- (xxi) That the scourges of poverty, ignorance, disease and other afflictions should be eliminated from the face of the nation, and that disadvantaged and vulnerable groups, as well as groups which are being discriminated against, should be empowered to put an end to their disabilities.
- (xxii) That sporting, artistic, cultural and intellectual pursuits contribute significantly to the growth of the nation, and that consistent support should be given to such efforts.

OBJECTS

The objects of the Democratic Labour Party are:

- To adhere to, support, develop and implement in all ways possible the Philosophy and Principles of the Democratic Labour Party.
- (ii) To mobilize and enroll into the fold of the Democratic Labour Party progressive persons of any race, colour or creed who accept a democratic form of government and who recognize the focal role the labour and human resources generally must continue to play in the evolution of an improved social economic order in Barbados.
- (iii) To secure the election of members of the Democratic Labour Party to the Parliament of Barbados and to such other elected bodies within or outside of Barbados.
- (iv) To nominate members to serve on such bodies as may be appropriate for furthering the philosophy, principles and interests of the party.
- To work in close collaboration and coordination with persons and bodies sharing similar principles or objectives.
- (vi) To propagate the party's philosophy, principles, programmes, policies and objects through a comprehensive scheme of public

(1) The Membership Application Form when completed shall be forwarded immediately to the General Secretary of the Democratic Labour Party, where:

(a) The General Secretary shall first check the completed Membership Application Form for accuracy, and then submit the form to the earliest possible meeting of the Executive Council, which shall thereupon approve or otherwise deal with the application as it thinks fit;
(b) The General Secretary shall maintain at the Headquarters of the Democratic Labour Party a Party membership Registration on which shall be entered the names, addresses, dates of birth and other relevant information from the Membership Application Form of all persons who have been admitted to membership of the Party;

(c) The General Secretary shall also maintain at the Headquarters of the Democratic Labour Party a membership Register of all persons admitted as members of the Party and allocated by Executive Council into Constituency Branches;

(d) The General Secretary shall send to the appropriate Constituency Branch Secretary a list of the names and relevant details of all members admitted to the Party after each meeting of the Executive Council at which such members were admitted to membership.

(2) Members shall notify the General Secretary, as well as the relevant Constituency Branch Secretary, of any change in their address.

A Branch may organize social activities or functions for the purpose of raising funds and may apply any such funds raised or any part thereof to meet the necessary expenses of the Branch. The General Secretary and the Branch Secretaries shall enter in appropriate books of account a record of all moneys received by them and all moneys paid out; and shall have all books, receipts, and financial records ready for inspection by the Auditors at any time after twenty-four hours notice of an inspection has been given. The books, accounts and financial records of the Party
			Headquarters and of the Branches shall be audited by Auditors appointed by the Annual Conference on the nomination of the Executive Council. The Auditors shall not later than a month after the end of each financial year submit to the Executive Council a certified report for the financial year.

- (2) The Grievance Committee shall be responsible for the handling of Grievances of members concerning their relationship with other Members; the functioning of organs of the Party; the functioning of Branches or the officers of branches and such other matters as do not fall to be determined by the Disciplinary Committee.
- (3) The Disciplinary Committee shall address issues relating to the breach of the Party's Constitution, Rules, Standing Orders or directives, or any conduct injurious to the interest, reputation, policies, principles and general well-being of the Party.
- (4) Each committee shall be chaired by a member of the Executive Council selected by the President from among the members of the Council and shall conduct such hearings as are required to deal with grievance or disciplinary matter and thereafter shall forward a report to the General Council with recommendations.
- (5) The sanctions available to the General Council shall be : warning, reprimand or expulsion.
- (6) The General council may delegate its powers in disciplinary matters Or matters of grievance to the Executive Council.
- (7) Members appearing before either of the Standing Committees are e Entitled to be represented by a legal representative.
- (8) For the avoidance of doubt, any member of the Democratic Labour Party who has joined another political party shall promptly loose his Membership of the Democratic Labour Party.

APPEALS (35) Should any member feel aggrieved by a decision of the General Council he shall have a right of appeal to the Annual Party Conference. Every notice of appeal shall be in writing and shall be delivered to the General Secretary within thirty days of the decision of the General Council. 36. Any member expelled in accordance with these Rules, or otherwise ceasing to be a member of the Party, shall forfeit all such rights to, or claims upon, the property and funds of the Party as he would enjoy by reason of his membership.

- (e) secure adequate development of the Constituency and ensuring that it obtains its fair share of the national cake;
- (f) contribute to and participate in the selection process of candidates and prospective candidates to contest elections;
- (g) organize activities within the Constituency for effective political campaigning, and maintain appropriate machinery to secure the election of Democratic Labour Party candidates for the Constituency to legislative and similar bodies;
- (h) conduct a programme of political, economic and social education within the Constituency, and train a cadre of party election officials to represent the interest of the Democratic Labour Party candidates in elections;
- work with other Branches and with affiliate bodies in a programme of mutual cooperation to promote the interests of the Party;
- (j) build up the membership of the Branch;
- (k) receive membership subscriptions, raise funds and make payments in respect of the activities of the branch and party, and maintain accounts at any registered bank or financial institution; and
- notify the General Secretary one month in advance of social activities and functions being organized for purposes of raising funds.

The Business of an annual general meeting of a Branch is:- (a) to receive and adopt the report of its Committee of Management for the past year including the Financial Statement; (b) to elect a Committee for the ensuing year; (c) to receive nominations under Rule 21; (d) to elect the Branch members to serve on the General Council; (e) to elect delegates for the next Annual Conference. 		
RECORDS AND RESOLUTIONS	48.	A full record of the proceedings of the Annual Branch Meetings, together with copies of any Resolutions to be submitted for consideration to the Annual Party Conference shall be sent to the General Secretary at Party Headquarters not later than fourteen days after such meeting.		
FINANCIAL YEAR	49.	The Financial Year of the Party and of all its Branches shall be from the first day of June to the thirty-first day of May in the Next calendar year.		
PARLIAMENTARY GROUP	50.	(a) The Parliamentary Group shall consist of all Party members of the House of Assembly and the Senate.		

The Political Leader shall be Chairman of the Parliamentary Group.

- (b) The Parliamentary Group shall meet at such times and in such places as the Chairman shall determine. All matters to be submitted to the Chairman at least one day before a meeting.
- (c) At meeting of the Parliamentary Group there shall be no requirement for a quorum except in such cases:
- (i) Where the Parliamentary Group is electing a Political Leader;
- (ii) Where the Parliamentary Group is meeting to discuss a matter relating to a policy position on which a vote has been called for by any member attending that meeting.
- (d) In such cases set out in section (c) (i) and (ii) a quorum shall be all of the Members of the House of Assembly who are members of the Party.
- (e) Where any matter set out at section (c) (i) and (ii) falls to be determined, a member who has been summoned in writing to a meeting twice but fails to attend without reasonable excuse shall not be counted in determining the requirements for quorum.
- (f) A person other than a member as set out in sub-paragraph (a) may be selected by the Parliamentary Group to be its Secretary or to attend, subject to the Chairman's approval, and participate, without voting rights, at any meeting.
- (g) The following matters shall be reserved for the consideration and decision of the Parliamentary Group:
- (i) the election of a Political Leader;
- (ii) the procedure governing its meetings;
- the Parliamentary position of the Party on any issue, matter, policy, law, regulation, resolution, motion or selection before the House of Assembly and Senate, subject to consultation where appropriate, with the General Council;
- (iv) any other matter which, subject to this Constitution, the Political Leader determines.
- (h) The Political Leader is the person who commands the support of the majority of members of the Parliamentary Group in the House of Assembly;

	(i	(i)	The General Council by majority vote may summon in writing any member of the Parliamentary Group to appear before the General Council for the purpose of:
			(a) having that member explain or defend before the General Council in respect of any matter relating to any matter of policy falling within that member's portfolio or shadow portfolio.
			 (b) having that member account before the General Council in respect of any concerns about the general discharge of that member's parliamentary duties.
		(j)	The Parliamentary Group shall furnish to the General Council at every meeting of the General Council a report of any sittings of the House of Assembly or the Senate taking place since the previous meeting of the General Council.
ORGANISATION	51.	(a)	There shall be organizations known, respectively, as the Young Democrats, the Democratic League of Women, Overseas Branches, The Academy of Politics and such other bodies as may from time to time be established by or with the approval of the Executive and General Councils.
		(b)	Each organization shall be authorized to adopt its own Constitution and Rules and engage in such activities as its Committees of Management determine subject to the approval of the Executive Council.
		(c)	Each organization shall report to the Executive Council in such manner and form and at such times as the Executive Council directs.
		(d)	Any matter, dispute, conflict or disagreement relating to the interpretation of the Constitution, Rule, Standing Orders, Rulings, Motions, Resolutions of any organization may be referred in writing, supported by the signatures of any ten members of the Party, to the General Council whose decision shall be final.

No Branch shall enter into affiliation with, or in any way lend its support to any political or other organization except on the directive of the General Council signed by the President and General Secretary.
